



A link that you will receive after signing the building agreement will give you access to your personal buyer portal. In this portal you can go through everything at home, behind your computer. Here you can find also the sales contract documents (technical description, sales contract, drawing, etc.). You can also communicate with your buyer guide via the buyer portal. The questions and answers can be found on your portal.



Throughout the renovation process, we pay a lot of attention to informing the buyers of our apartments. The personal guidance by your buyer's guide ensures that you stay informed of developments throughout the construction period. If you have any questions, please contact your buyer's advisor. Your buyer's guide can be reached via your buyer portal. Please keep in mind that it can take up to approximately 10 working days for the processing of your questions. ### 2.1 Sizing

The positions indicated on the drawing (height and width) are approximately measures. If you would like additional wall sockets or other electricity points, please indicate these including the dimensions in cm on the option drawing.

## 3. KITCHEN, PLUMBING, TILING AND INTERIOR DOORS



### 3.1 Kitchen

The apartments in Kibaima Apartments project are standard equipped with a complete kitchen, including appliances. The kitchens are fully equipped with an oven, fridge-freezer, dishwasher, stove, sink and kitchen tap. See Annex C for a detailed description of the kitchen and appliances per unit.



### 3.2 Sanitary

The apartments come standard with 1 full bathroom.

The sanitary ware is from the brand Fortifura and INK. See Annex C for a detailed description of the sanitary facilities. It is not possible to cancel the sanitary facilities.



### 3.3 Tiles

The apartments are standard equipped with tiling in all areas. The colour of the tiles for the interior floor can be found in Annex C.



### 3.4 Interior doors

In the Kibaima Apartments project, there are no options offered for interior doors.

### 4. MISCELLANEOUS



### 4.1 Work by third parties

After the delivery of your apartment, you can of course have changes made (by third parties). We would like to emphasise that only changes that have been carried out by or on behalf of TVD Real Estate VBA before delivery are covered by the guarantee and guarantee scheme. TVD Real Estate VBA is not liable for damage to materials and installations that are the result of work by third parties and/or under its own management. Also, work carried out by third parties or under own management is not covered by the warranty. It is not permitted to carry out work or changes to the apartment yourself before completion. It is also not possible to supply your own materials, such as tiling and sanitary ware, due to the warranty and insurance regulations.



#### 4.2 Guarantee

For all delivered work, the standard warranty scheme of 12 months applies. If standard facilities are cancelled, the guarantees relating to this will lapse. We would like to point out that if you have any changes made to the Apartment yourself or by third parties after delivery, the guarantees will expire completely.



### 4.3 Slight deviations of products

The products quoted are based on a standard product, with minor deviations in color and/or design. TVD Real Estate VBA is not liable for any colour nuances that arise from the use of different types of material (plastic, ceramic, sheet metal). Products with name and type can be replaced by equivalent products, without this being announced in advance. If products are no longer available at the time of execution, you will be informed as soon as possible. Despite the great care we take in construction, we cannot prevent cracking that is the result of drying, hardening or shrinkage of materials.



### 4.4 Contradictions

In the event of any discrepancies between the buyer's list and the corresponding drawings, the buyer's list shall prevail. In the event of any discrepancies between the buyer's list and the technical description, the technical description shall prevail.



### 4.5 Price

All prices mentioned in the buyers list include BBO/BAZV (Turnover Tax). Prices mentioned in quotations are only valid for the period of validity of the quotation. Increase of prices due to government requirements will always be passed on to you.
